Affordable Healthcare Plan Details:

Medical Services

As used in this Agreement, the term Medical Services shall mean those medical services that the Physician/Nurse practitioner is permitted to perform under the laws of the State of Florida and that are consistent with his/her training and experience as a Family Medicine physician/Nurse Practitioner, as the case may be.

The following services shall be provided as medically indicated:

- Routine medical visits for chronic issues and acute illnesses
- Wellness Visits including Health Risk Assessment
- Vision and Hearing Screening
- EKG
- Psychosocial Screening
- Phlebotomy
- Rapid strep, flu, urinalysis, urine pregnancy test at no extra charge
- COVID19 test (additional fee)
- Medication injections: Solumedrol (steroid), Toradol (ketorolac), Phenergan (promethazine) when medically appropriate at no extra charge
- Tuberculosis test (PPD)
- Joint drainage and steroid injection (extra charges may apply)
- Skin biopsies (pathology fee applies)
- Skin tag, wart, and other benign lesion removal (extra cost may apply)
- Additional services may be added by Physician/Nurse Practitioner on an ongoing basis

Terms of Service:

Verad Minute Clinic shall provide the Patient with the following non-medical services:

1. Physician/Nurse Practitioner access via cell phone, texting, and video chat by arrangement. Patients will receive a special cell phone number to reach the Physician/Nurse Practitioner or a representative. Physician/Nurse Practitioner will respond as soon as possible to text messages but does not guarantee immediate response. Always call 911 for medical emergencies.

2. E-mail access. Patients shall be given the Physician/Nurse Practitioner's email address to which non-urgent communications can be addressed. Such communications shall be dealt with by the Physician/Nurse Practitioner or staff member of the practice in a timely manner. Patients understand and agree that email and the internet should never be used to access medical care in the event of an emergency, or any situation that a patient could reasonably expect may develop into an emergency. Patients agree that in such situations, when a Patient cannot speak

to a physician/Nurse Practitioner immediately in person or by telephone, that Patient should call 911 or the nearest emergency medical assistance provider and follow the directions of emergency medical personnel.

3. No wait or minimal wait appointments: Every effort shall be made to assure that the patient is seen by the Physician/Nurse Practitioner immediately upon arriving for a scheduled office visit or after only a minimal wait. If a physician/Nurse Practitioner foresees a minimal wait time is not possible, the patient shall be contacted and advised of projected wait time.

4. Same Day/ Next Day appointments: When a patient calls the office prior to noon on a normal business day to schedule an appointment for an acute medical problem, every reasonable effort shall be made to schedule an appointment with the Physician/Nurse Practitioner on the same day. If a patient calls after noon on a normal office day for an acute issue, every reasonable effort shall be made to schedule the Patient's appointment with the Physician/Nurse Practitioner on the following normal business day. Verad Minute Clinic shall make every reasonable effort to schedule an appointment for the Patient as soon as possible for chronic/ routine medical issues, but cannot guarantee same day/next day visits.

5. Telephone appointments: Patients will have the option of a telephonic consultation when appropriate with the Physician/Nurse Practitioner, to be scheduled at the convenience of both parties.

6. Visitors: Family members temporarily visiting a Patient from out of town may, for a two-week period take advantage of the services described above. Medical services rendered to patients' visitors shall be charged on a fee-for-service basis.

7. Specialists. Verad Minute Clinic Physician/Nurse Practitioner shall coordinate with medical specialists to whom the Patient is referred to assist Patient in obtaining specialty care. Patients understand that fees paid under this Agreement do not include and do not cover specialists' fees or fees due to any medical professional other than the Verad Minute Clinic Physician/Nurse Practitioner. While your primary care physician/Nurse Practitioner will do everything possible to manage conditions within their scope of practice, please be aware there are circumstances in which a specialist is necessary for medically appropriate care.

8. Hospitalization coordination: If a patient needs to be admitted to the hospital, Verad Minute Clinic Physician/Nurse Practitioner will help coordinate the admission with the hospitalist at the appropriate facility. Hospital charges are the responsibility of the patient. The patient's monthly fee to Verad Minute clinic does not cover hospital charges.
